ORDINANCE NO. 1 - 2022

AN ORDINANCE TO AMEND THE CODE OF ORDINANCES OF NORTH LEBANON TOWNSHIP PROVIDING FOR CHANGES IN THE FOLLOWING SECTIONS: Chapter 1 – Administration and Government – Part 8 – Drug and Alcohol Program; Chapter 13 – License and Permits – Part 2 – Junkyard Regulations, Section 13-206 – Burning Restricted; Chapter 15 – Motor Vehicles – Part 1 – General Regulations, Section 15-112 – Snow Emergency Routes Designated.

BE IT ENACTED AND ORDAINED, BY THE BOARD OF SUPERVISORS OF NORTH LEBANON TOWNSHIP, LEBANON COUNTY, PENNSYLVANIA, THE FOLLOWING ADDITIONS AND AMENDMENTS TO THE CODE OF ORDINANCES OF NORTH LEBANON TOWNSHIP, AS FOLLOWS:

Section 1. Chapter 1, Part 8, Drug and Alcohol Program is repealed in its entirety. The policies set forth in this Chapter and Part have been incorporated into the North Lebanon Township Personnel Manual.

Section 2. Chapter 13, Part 2, Junkyard Regulations, § 13-206. Burning Restricted shall be amended to state:

§ 13-206. Burning Prohibited.

Motor vehicles, gasoline, grease, oil, tires, or similar materials which could be dangerous or tend to produce noxious smoke or odors shall not be burned at any time on junkyard premises.

Section 3. Chapter 15, Part 1, General Regulations, § 15-112. Snow Emergency Routes Designated, Paragraph 1 shall be amended to add the following streets:

Snapdragon Court
Loretta Drive
Linda Drive

All other provisions in § 15-112 shall remain in effect without amendment.

Section 4. All other provisions of the North Lebanon Township Code of Ordinances not amended by this Ordinance shall remain in full force and effect.

Section 5. Any Ordinance and any amendments thereto, or in any part thereof unless otherwise specified, inconsistent with the provisions of this Ordinance are hereby expressly repealed. Should any section of this Ordinance be declared by the Court to be unconstitutional or invalid, such

decision shall not affect the validity of the ordinance as a whole, or any part thereof, other than the part so declared to be unconstitutional or invalid.

Section 6. This Ordinance shall become effective five (5) days after its enactment by the Board of Supervisors of the Township of North Lebanon, County of Lebanon, Commonwealth of Pennsylvania.
