ORDINANCE NO. 2 - 2022

**AN ORDINANCE TO AMEND CHAPTER 6 (CONDUCT) OF
THE NORTH LEBANON TOWNSHIP CODE OF
ORDINANCES, LEBANON COUNTY, PENNSYLVANIA, TO
RESTRICT THE OPERATION OF CERTAIN TYPES OF
MOTOR VEHICLES WITHIN THE RURAL RESIDENTIAL
(RR) DISTRICT.**

WHEREAS, the Board of Supervisors of North Lebanon Township adopted Ordinance 2-2010 on March 15, 2010, codified in Chapter 6, Part 8 of the North Lebanon Township Code of Ordinances, which prohibits certain conduct in residential zones; and

WHEREAS, Section 6-801 of the North Lebanon Township Code of Ordinances prohibits the operation of any ATV, dirt bike, or similar type of motor vehicle within any area of North Lebanon Township which is zoned as R1 or R2; and

WHEREAS, the Board of Supervisors have determined that the operation of such types of motor vehicles create a nuisance to neighboring property owners within the residential areas of the Rural Residential (RR) zoning district; and

WHEREAS, the Board of Supervisors have determined that it is in the best interest of the health, safety, and welfare of the residents of North Lebanon Township to regulate and restrict the operation of any ATV, dirt bike, or similar type of motor vehicle within any area of North Lebanon Township which is zoned RR.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by the Board of Supervisors of North Lebanon Township, Lebanon County, Pennsylvania, that Ordinance 2-2010, as codified in Chapter 6 of the North Lebanon Township Code of Ordinances, Conduct, Part 8, Conduct Prohibited in Residential Zones of North Lebanon Township, shall be amended as follows:

Section 1. Chapter 6, Part 8, §6-801. Conduct Prohibited is hereby amended to state as follows:

It shall be unlawful for any person or persons to operate or to permit the operation of any ATV, dirt bike, or similar type of motor vehicle within any area of North Lebanon Township which is zoned as an R1, R2, or RR District.

Section 2. All other provisions of Chapter 6, Part 8 of the North Lebanon Township Code of Ordinances not amended by this Ordinance shall remain in full force and effect.

Section 3. Any Ordinance and any amendments thereto, or in any part thereof unless otherwise specified, inconsistent with the provisions of this Ordinance are hereby expressly repealed. Should any section of this Ordinance be declared by the Court to be unconstitutional or invalid, such

decision shall not affect the validity of the ordinance as a whole, or any part thereof, other than the part so declared to be unconstitutional or invalid.

Section 4. This Ordinance shall become effective five (5) days after its enactment by the Board of Supervisors of the Township of North Lebanon, County of Lebanon, Commonwealth of Pennsylvania.
