 - e. Written certification from NLTMA stating there is ample capacity for collection and conveyance within their system for this development and this request will not create a hydraulic or an organic overload over the next 5 years.
 - Written certification from City of Lebanon Authority (CoLA) stating there is ample capacity for conveyance and f. treatment at the sewage treatment plant for this development and this request will not create a hydraulic or an organic overload over the next 5-years
 - Written confirmation from CoLA stating they have capacity to service the project with public water g.
 - Plot plan h.

F. **Designated Municipal Official**

The Township Manager or Chairman of the Board of Supervisors shall be designated as the municipal official who shall sign Ι. the postcard mailer and return to DEP/DLA.

TAPPING FEES

Α. Sewer Treatment Capacity and Tapping Fees

Each owner shall be required to first purchase sewer treatment capacity at the CoLA Treatment Plant by making application to the NLTMA and paying the sewer treatment capacity fee and the NLTMA tapping fee. The number of EDU's required to be purchased shall be according to the EDU chart that is adopted by the NLTMA Board, or in special cases, by agreement. The sewer treatment capacity fee may change at the discretion of CoLA and the owner will be charged accordingly. No sewer treatment capacity shall be guaranteed until such time as sewer treatment capacity at the CoLA Treatment Plant is granted. The NLTMA tapping fee is calculated by the Authority Engineer as set forth in Resolution 02-2005. This is for collection and capacity within NLTMA's lines.



G. Reimbursement

The Developer shall be entitled to reimbursement under the Municipality Authorities Act from any future connections made within ten (10) years outside of the development to any sewer and water (Township water service area only) line constructed by the Developer at his expense and subsequently dedicated to the Authority. The Authority and Developer shall enter into a Reimbursement Agreement in accordance with Section 5607(d)(31) of the Pennsylvania Municipality Authorities Act.
