Old Business

Ebenezer Beautification Committee BBQ Fundraiser – The Board of Supervisors agreed with the recommendation provided by the Parks & Rec Board. The Ebenezer Beautification Committee will hold their chicken BBQ fundraiser at the intersection of Jay Street and Route 72 below the dam breast on May 15, 2024.

Keystone Novelties – The Board of Supervisors agreed with the recommendation provided by the Parks & Rec Board. Keystone Novelties were granted approval to use the vacant area at the intersection of Jay Street and Route 72 below the dam breast to set up their fireworks tent. The fee was set at \$1,000.00.

New Business

GO Lebanon 2024 – Molly was contacted by WellSpan regarding the plans for GO Lebanon in 2024. This program encourages kids to be active and get out of the house by using a map to find hidden posts at various parks. They have used Lions Lake and Community Park in the past as one of their locations. They are requesting to use Lenni Lenape this year. Molly is looking for a recommendation from the board members.

MOTION: Motion was made by Mark and seconded by Corey to recommend approval of GO Lebanon using Lenni Lenape Park in 2024. Motion approved unanimously.

Northern Lebanon Little League – Job Box Request – On behalf of Northern Lebanon Little League, Dwayne is requesting permission to place job boxes at each Community Park baseball field. This would allow the league to store supplies needed to maintain the fields before, during, and after any games. Molly is looking for a recommendation from the board members.

MOTION: Motion was made by Mark and seconded by Corey to recommend approval of Northern Lebanon Little League placing job boxes at each Community Park baseball field. Motion approved unanimously.
