## SPRING CLEANUP

Only **ONE** sweep of the Township will be made.

Spring clean up is for **BRANCHES, STICKS & TWIGS ONLY!** All branches must be cut to **6 foot in length or smaller** and be **less than 6 inches in diameter**. Place in **neat 6 foot to 8 foot long piles PARALLEL to the curb**. Piles may be **as high as 4 feet**.


Any items placed in open barrels or bins will be collected and the receptacles will be left on the curb. Please **DO NOT** include root systems or sod of any kind. Any unacceptable items will be left on the property and will be the owners' responsibility to discard. The Township **will not** drive down private lanes/alleys to pick up material. All material must be brought to the end of the lane/alley to be accessible for pick up from the nearest street. Please keep piles away from obstructions such as poles, mailboxes, cars, etc. The Yard Waste Facility is available for those who miss the collection and have a Yard Waste Access Card.

## Yardwaste Card

To purchase a Yard Waste Access Card, Stop by the Township Office any time during our regular office hours. The fee is \$50 and is valid for the calendar year.

### Utilize all the Perks:

- \*Access to self serve mulch
- \*Request help with scoop/delivery service for small equipment use fee
- \*Access to drop area for leaves, sticks and yard rubbish throughout the year




## Changes Coming March 2025

Beginning in March, there will be new designated areas for yard waste drop off. Four (4) different bays will be located along the west side of the yard. Each bay will be for specific items as follows:

- Branches & shrubs
- Garden residue
- Leaves
- Grass clippings

Each section will be labeled accordingly. The mulch pile will remain along the south east corner of the yard for access.

## A MESSAGE FROM THE LEBANON COUNTY REGIONAL POLICE



The LCRPD suggests all residents to go to the Lebanon County Regional Police Department Website <https://lebanon.crimewatchpa.com/lcrpd> and subscribe to keep informed with the police department and community. If you look under the forms tab, you'll find you can register your pets, alarms, handle with care, and camera registry. Please be advised this information is not open to the public and is private for police personnel only. If you have cameras and register them, this will assist us in our investigations.

Please be aware of a current scam where emails are being sent indicating fraudulent activity on various online accounts. They will tell you they accidentally put money into your account as an over refund and request you send them repayment. They might request to pick up cash as repayment from your residence. If this occurs, do not provide money or information and call the police to make a report.

## SPRING & SUMMER PROJECTS

**LIONS LAKE PARK** continues to undergo renovation. Fishing will **NOT** be permitted at Lions Lake Park in 2025. The park will be open to the public and open for pavilion rental, but caution is advised to avoid all active work zones.



### JAY STREET WALL PROJECT

The Township intends to replace the existing deteriorating retaining wall along Jay Street. We are currently working with our engineer to prepare the design and construction drawings. The Township was awarded a \$300,000 LSA Grant for this project. The next steps after design are to place the project out for bid and subsequently award the bid to the lowest bidder. It is our goal to have this project completed by the end of this year. At some point during the construction process we may need to close Jay Street for a short period of time.



### PAVING

Spring brings warm weather and work crews. Please use caution while traveling and observe signs, flaggers, and workers on the roads. This year's paving projects include:

- **East Kercher Ave**

*(Between Prescott Dr & Mt. Zion Rd)*

- **Joel Drive**

*(Between N 15th Ave & the cul-de-sac)*

Some preliminary work will be done prior to the start of the paving. Expect delays, especially during peak travel times. Stay alert and drive with caution. **HELP** keep our workers **SAFE!**

## MOWING & STORM WATER MANAGEMENT

Township ordinances prohibit the disposing of grass clippings in nearby storm water inlets, swales and basins. **Blowing grass into the street is also prohibited.** Grass that is blown into the street ultimately ends up in the storm sewers and pollutes our creeks and rivers. **Any such activity is a violation of township ordinances and subject to fines and penalties.**




Do your part by reporting any spills, illicit discharges, or suspicious dumping into storm drains to your local municipality.

### **Windy Days & Your Garbage**

Per NLT Solid Waste Ordinance, "It shall be the responsibility of the owner or lessee of the real estate to keep all garbage, refuse, or other materials at all times within the receptacle, and such owner/lessee shall immediately clean up any such items that are outside the receptacles." Keep lids on **tight and secure & weigh them down.** Garbage and recycling is your responsibility until it is collected by your hauler. **Please do not litter by leaving items blow into the street, clogging drains or onto neighboring properties.**

## WASTEWATER

Flushable wipes are NOT flushable despite their advertising. Flushable wipes do not dissolve in the sewer system but instead actually clog our system. The wipes collect in the pumps and valves causing clogs and back-ups. Clogs in sewer pipes can lead to dangerous sewage spills into the community and can be very costly to repair. Keeping our community safe from sewage spills and keeping maintenance costs down are very important to us. Remember: "Only place toilet paper in the toilet. Put trash where it belongs...in the trash."

**If you haven't received your bill a few days after the mailing date, we suggest you call the Township Office (717-273-7132) for your balance to avoid any late charges or penalties.**

Payment can be mailed into or dropped off at the Township Office in the form of Cash, Check or Money Order. Card payments are **NOT** accepted here in the office. **\*Card payments can be made ONLINE ONLY.**

\*ACH transactions through your bank **do not** automatically apply to your sewer account. The bank deducts the amount from your bank account, then prints out a paper check and mails it to the Township via the United States Postal Service. Your sewer account only gets credited once we receive the check. If you use this process the Township recommends having your sewer payment deducted from your account at least **seven to ten business days prior to the due date**. **If the check arrives in the Township office after 4 pm on the due date, it will be considered late and your sewer account will be charged the late fee.** The only way to have your payment automatically apply is to pay using OUR online portal.

\* **Please note:** You will need your **ACCOUNT NUMBER** and your **CID NUMBER**, both of which are located on your bill. You will have to add each Sewer & Stormwater account separately along with separate payment methods in order to utilize the online payment portal. If you need help, please call the office.

In the fall of 2024, the North Lebanon Twp Municipal Authority paid off the sewer debt, which in turn lowered our Operation & Maintenance costs for 2025. The Authority has reduced the "Sewer Customer Charge" from \$78.00/quarter to \$60.00/quarter per EDU. However, the City of Lebanon Authority is raising their rates from 4.07/1000 gallons to 4.19/1000 gallons starting April 1, 2025 for their usage fee. Despite the raise in the City's rates, you should still notice a slight decrease in your sewer bills.
