Old Business

Northern Lebanon Little League – Portable Toilet Request – The Board of Supervisors approved at their March meeting to allow the league to place portable toilets at two of the baseball fields. One would be placed at the North Lebanon Township field and the other at the Lions Lake field pending completion of the restoration project area around the field.

New Business

Ebenezer Beautification Committee – During the Board of Supervisors March meeting, they approved the Ebenezer Beautification Committee holding their annual chicken BBQ fundraiser at the intersection of Jay Street and Route 72 below the dam breast to be held on

Wednesday, May 21, 2025 from 6 AM to 6 PM. Due to the committee submitting a request later than normal, this year's approval went before the Board of Supervisors first. Thus, the Park & Recreation board did not have a chance to review or provide a recommendation. This option allowed the committee to start selling their tickets prior to April.

Township Dog Park – Discussion was tabled for now, until further notice.

Ebenezer Dam Inspection – Inspection was completed on March 20, 2025, with no noted concerns. All members were provided with a copy of the inspection report.

Park Restrooms Re-Open – The restrooms for all (3) three Township parks were reopened for the season on Monday 3/31/25.
